



## Hall of Fame Award

The Hall of Fame award recognizes those individuals who are pioneers and who have made a significant contribution to the motor coach industry.

### Qualifications

#### Bus Operators

1. Minimum 25 years of service to the motor coach industry.
2. Minimum 20 years of service in a management capacity with an operating company.

#### Tour Operators

1. Minimum 15 years of service in the travel/tour business.
2. An individual who conforms to the OMCA Code of Ethics.
3. Minimum 10 years as a member of OMCA.
4. Significant contribution to the industry as a leader and innovator.

### Instructions for Nominations

#### Bus Operators

Nominations must be made by an OMCA bus operator member and supported by two (2) other operator members.

#### Tour Operators

Nominations must be made by an OMCA tour operator or supplier member and supported by one (1) other tour operator or supplier member.

#### Bus and Tour Operators:

1. Provide details on the above criteria using the form following these instructions.
2. A historical outline indicating the nominee's involvement in the industry must be attached to the nomination form; it must document the nominee's contributions and achievements over the years.
3. Please include any other details that the Awards Committee should consider in determining the merits of the nomination.
4. The Awards Committee will select a maximum of three (3) nominees per year.

### Evaluation

When a nomination has met the qualification criteria listed on this page, the Awards Committee will also consider the following:

- Contribution to the nominee's company(s);
- Contribution to the nominee's community

### Awards and Prizes

Each winner of this award will receive:

- Complimentary invitation for the winner(s) and a guest to attend an OMCA Luncheon, during which he or she will receive the award;
- Industry and external publicity
